1.0 JPL invites sealed bids from eligible bidders for Coal Handling Plant (CHP) inside power plant boundary package of 2400 MW (4 X 600 MW) O P Jindal Super Thermal Power Plant situated in Tamnar, District Raigarh, State of Chhattisgarh, India, as per the scope of work mentioned herein after.

2.0 **Scope of Work :- The brief scope of Work is as under:**

The brief scope covers Design, engineering, manufacture, testing at manufacturer's works, assembly, packing, forwarding, supply and delivery of 3000 TPH Coal Handling Plant & auxiliaries including 2 no. 3000 TPH reversible type rail mounted Stacker Cum bucket wheel Reclaimer, Conveyor system, Traveling Trippers, Magnetic separators, belt weighers, Electric motors, PLC system, Local instruments, Dumper unloading system, Technological & non technological structures, Dust extraction & suppression system, Ventilation system etc. including transportation and transit insurance, spares, tools & tackles including erection, testing, commissioning and PG Testing of above mentioned equipments and supervision of civil works (execution of civil works at Site is not included in this package) as per specification and scope defined in Bidding Documents, required for 4 X 600 MW O.P Jindal Super Thermal Power Project at Tamnar, Raigarh district of Chhattisgarh.

3.0 Qualifying requirement, benefits/ exemptions to supplies for this package as per provisions of Government of India Notifications for Mega Power Project, Cost of bidding documents and requirements regarding Bid security etc are elaborated below:

**5.0** All bids must be accompanied by Bid Security for an amount equivalent to Indian Rs.1,50,00,000.00 (Rupees One Crore Fifty lacs only), either in bid currency or in US Dollars as per the performa of Bid Guarantee attached in Section-I, Condition of Contract of Bid Documents. If the Bid Price is quoted in more than one currency, the Bid Security shall be in US Dollars. Bids not accompanied by the requisite Bid Security in a separate sealed envelope or bids accompanied by the Bid Security of inadequate value shall not be entertained and in such cases, bids shall be returned to the Bidders without being opened.

**6.0 Benefits/Exemptions to suppliers for Mega Power Projects**

This project fulfils the laid down criteria for Mega Power Project status subject to fulfilment of certain requirement as existing under the law and JPL expect concession in Custom Duties, Excise Duty, Sales Tax etc. Accordingly, supplies of goods for this package will be eligible for benefits/ exemptions as per provisions of relevant notifications of the Govt. of India.

In respect of excise duty, the Owner will provide the certificate of Mega Power Plant to the Contractor along with Project Authority Certificate specifying various items/quantities/values for procurement of various materials required for completion of the civil, structural & architectural works covered in this Contract.

### Section-I

This Project Authority Certificate shall be issued to the Contractor for each procurement by the Authorized person of the Owner. Once the Owner provides the said certificate, it is the responsibility of the Contractor to get exemption/refund on this account from the concerned department. However, the Owner shall provide all necessary assistance and guidance to the Contractor in getting the necessary certificate from the concerned department/the Ministry. The Contractor will inform the Owner the date by which they require the mega power certificate from the Owner. If the Owner fails to provide the mega power plant certificate to the Contractor, in such case, the Excise Duty alongwith Education Cess (if applicable) shall be reimbursed by the Owner after receipt of documentary evidence from the Contractor. However, in such case, any increase in other taxes and duties shall be on account of the Contractor.

#### 7.0 Qualifying requirement for Bidders

In addition to the requirement stipulated in Clause 13.2.1 (e) under Part-B, Instruction to Bidders (ITB) of Section- I: Condition of Contract, the Bidder should also meet the qualifying requirement stipulated hereunder:

- i) The average turn over of the Bidder during the preceding best three out of last five completed financial years as on date of the bid opening shall not be less than Indian Rupees 90 Crores (Rupees Ninty Crores Only).

And

- ii) The average Internal resource generation of the bidder during the preceding three completed financial years as on date of the bid opening shall not be less than Indian Rupees 15 Crores (Rupees Fifteen Crores only)

And

- iii) The bidder must have designed, supplied, erected and commissioned at least 2 number Coal Handling Plants, each of capacity not less than 2000 TPH, which should be in successful operation for at least two years as on the date of bid opening.

And

- iv) The bidder should have designed, supplied, erected and commissioned at least 2 numbers stacker cum reclaimer of capacity not less than 1500 TPH in coal application, which should be in successful operation for at least two years as on the date of bid opening.

Section-I

- v) The Bidder must have executed single contract of similar work of value of around Indian Rupees 150 Crores (Rupees One Hundred Fifty Crores only) in last five years.

Or

The Bidder must have executed two contracts of similar work with value of each contract around Indian Rupees 90 Crores (Rupees Ninety Crores only) in last five years.

Notwithstanding anything stated above, the Owner reserves the right to assess the Bidder's capability to perform the work, should the circumstances warrant such assessment in the overall interest of the Owner.

- 8.0 JPL reserves the right to reject any or all bids or cancel/withdraw the Invitation for Bids (IFB) without assigning any reason whatsoever and in such case no Bidder/intending Bidder shall have any claim arising out of such action.
- 9.0 A complete set of Bid Documents may be purchased by any interested Bidder on submission of written application and payment (non-refundable) of the cost of the documents as mentioned at clause 4.0 above in the form of a **crossed Account Payee Demand Draft in favour of Jindal Power Limited payable at New Delhi**. Issuance of Bid Documents to any Bidder shall not construe that such Bidder is considered to be qualified. Bids shall be submitted and opened at the address given in clause 4.0 above in the presence of Bidder's representative who choose to attend.
- 10.0 The complete Bidding Documents are also available (during bid selling time only) at our website <http://www.jindalpower.com>. Interested bidders can download the Bidding Documents and commence preparation of bids to gain time. However, they will be required to purchase the Bid Documents from the address given in clause 4.0 above during the selling period, which will be duly authenticated by the executive issuing the documents. **The bid document not purchased within the specified period will not be accepted by the Owner**. In case of any discrepancy between the documents downloaded by the prospective bidder and the Bid documents (hard copy) issued by JPL official, the latter shall prevail.
